#### **Religious Education Intent**

At Wrotham School, Religious Education (R.E) is a vital part of our broad and balanced curriculum. Although we are an Academy without a religious designation, we recognise the importance of equipping students with the knowledge, understanding, and skills to navigate and appreciate the diverse religious and non-religious worldviews that shape our society and the wider global community.

In line with the Kent SACRE Agreed Syllabus, our intent is to:

- Promote knowledge and understanding of a range of religious and non-religious worldviews, including: Christianity, Islam, Sikhism and Buddhism.<sup>1</sup>
- Encourage respect, tolerance, and empathy by exploring how beliefs influence individuals, communities, and cultures, helping students to understand different perspectives and challenge prejudice.<sup>2</sup>
- Develop critical thinking skills, enabling students to reflect on and evaluate different worldviews, as well as their own beliefs, values, and assumptions.<sup>3</sup>
- Foster spiritual, moral, social, and cultural development, contributing to the personal growth of our students and preparing them for life in modern Britain.<sup>4</sup>
- Encourage enquiry-based learning, promoting curiosity and deepening students' ability to ask thoughtful questions and explore complex issues of meaning, purpose, and ethics.<sup>5</sup>

## **Religious Education Implementation**

All academies have to provide R.E for all their pupils, except for those whose parents exercise the right of withdrawal.<sup>6</sup>

As an Academy without a religious designation we must not provide an R.E syllabus to pupils by means of any catechism (religious instruction) or formulary (religious doctrine) which is distinctive of any particular religious denomination.<sup>7</sup>

The implementation of our Religious Education curriculum includes:

#### Key Stage 3:

- Year 7 and 8-1 lesson per week (75 minutes) for three terms.
- Year 9- 1 lesson per week (75 minutes).

#### Key Stage 4:

- Religious Studies is offered as a GCSE Option qualification.
- Religious Education is also delivered in Progress Time through the celebration and teaching about different faiths and religions.

#### Key Stage 5:

• Religious Education- the celebration of different faiths is delivered in Progress Time.

#### **Syllabus**

At Wrotham School, we follow the locally agreed syllabus of 'Kent SACRE Agreed Syllabus for Religious Education 2022–2027.'

## **Collective Worship Intent**

'Collective worship provides a daily focal point in school life for the transmission and development of all that school stands for in terms of its beliefs, values, moral codes and community ethos.'9

At Wrotham School, our approach to Collective Worship reflects our status as a school without a religious designation, while fulfilling the statutory requirement to provide a daily act of Collective Worship that is wholly or mainly of a broadly Christian character. Our intent is to create inclusive, reflective, and meaningful opportunities that promote shared values such as respect, compassion, integrity, and resilience.

#### What is Collective Worship?

'Collective worship is the gathering together of the school community on a daily basis to think about, respond to, reflect on and consider issues that are important to them as individuals and as a community. It provides the opportunity for those who wish to do so to worship God (however defined or understood).'<sup>10</sup>

#### **Collective Worship Implementation**

As an Academy without a religious designation we must provide Collective Worship that is wholly or mainly of a broadly Christian character. As a school, we can reflect the religious backgrounds represented in our community, as long as the majority of our provision is broadly Christian.<sup>11</sup>

Our implementation of Collective Worship includes:

- 'Each pupil must take part in a daily act of collective worship unless they have been withdrawn by their parents, or if in the sixth form they have decided to withdraw themselves.'12
- 2. Collective worship is held at the start of the school day and this is a single act of worship for all pupils.
- 3. All acts of Collective Worship take place on the school premises.
- 4. Collective Worship reflective moments are marked by either playing music or a moment of silence.

## The Right of Withdrawal

In accordance with the Education Act 1996 and the School Standards and Framework Act 1998, parents have the legal right to withdraw their child, wholly or in part, from Religious Education (R.E) and Collective Worship. At Wrotham School, which is a school without a religious designation, we respect this right and will comply with any formal request for withdrawal.

However, we encourage families to engage in dialogue with us before making such a decision, as our approach to R.E and Collective Worship is inclusive and educational. Both are designed to promote understanding, reflection, and respect for a range of beliefs and values, supporting students' spiritual, moral, social, and cultural development.

- 'Parents have the right to withdraw their children from religious education and/or collective worship.'<sup>13</sup>
- 'From age 16, pupils can choose for themselves to opt out of collective worship if they wish.
   However, they cannot opt out of receiving religious education without parental consent until they are 18.'14
- To make a request for the right to withdraw your child from R.E and Collective Worship please write a written request to the Head teacher.

#### Monitoring

- Religious Education is monitored as part of Teaching and Learning through learning walks and the appraisal process.
- Religious Education is monitored through Line Management.


