There are two elements to the governance of the CET academies – local governance that is delivered via the Local Governing Committee (LGC), and Trust governance, delivered via the Trust Board. The Wrotham School LGC consists of a group of people who could be parents, community nominees, or academy staff, with a minimum of five and a maximum of nine people, and who are appointed by the CET Trust Board. - To help on the ground with the implementation of certain CET and School policies
- To offer challenging but positive and proactive support to the Headteacher
- To regularly review the School's performance in relation to the Key Performance Indicators (KPIs)
